

PRIVACY POLICY

Moscow

August 1, 2017.

The real Privacy policy of personal data (further – Privacy policy) works for all information which the websites located on the domain names www.impex-fund.com, www.impex.blog can receive about the User in usage time of the website of the Website, programs and products of the website.

1. DEFINITION OF TERMS

1.1. In the real Privacy policy the following terms are used:

1.1.1. "The administration of the websites www.impex-fund.com, www.impex.blog (further – Administration of the website)" – authorized employees on the managements of the website acting on behalf the Name of the organization which will organize and (or) carries out processing of personal data and also defines the purposes of processing of personal data, structure of the personal data which are subject to processing, actions (operation) made with personal data.

1.1.2. "Personal data" - any information relating to directly or indirectly to the defined or defined natural person (the subject of personal data).

1.1.3. "Processing of personal data" - any action (operation) or set of actions (operations) made with use of the automation equipment or without use of such means with personal data, including collecting, record, systematization, accumulation, storage, specification (updating, change), extraction, use, transfer (distribution, granting, access), depersonalization, blocking, removal, destruction of personal data.

1.1.4. "Confidentiality of personal data" - mandatory for observance by the Operator or the got access to personal data by other person the requirement not to allow their distribution without the consent of the subject of personal data or existence of other legal basis.

1.1.5. "The user of the websites (further - the User)" – the person having access to the Websites, by means of the Internet and using the Websites.

1.1.6. "Cookies" — the small fragment of data sent by a Web server and stored on the computer of the user which a web client or a web browser every time sends a Web server in a HTTP request in attempt to open the page of the appropriate website.

1.1.7. "IP address" — a unique network node address on the computer network built according to the IP protocol.

2. GENERAL PROVISIONS

2.1. Use by the User of the website means consent with the real Privacy policy and conditions of processing of personal user information.

2.2. In case of disagreement with Privacy policy conditions the User has to stop use of the website.

2.3. The real Privacy policy is applied only to the websites www.impex-fund.com, www.impex.blog. The websites don't control and don't bear responsibility for the websites of the third parties on which the User can follow the links available on the websites www.impex-fund.com, www.impex.blog.

2.4. The administration of the websites doesn't check reliability of the personal data provided by the User of the websites www.impex-fund.com, www.impex.blog.

3. PRIVACY POLICY SUBJECT

3.1. The real Privacy policy establishes obligations of Administration of the websites for nondisclosure and providing the mode of protection of confidentiality of personal data which the User provides at the request of Administration of the website at registration on the websites or at execution of the order for purchase of goods (if such option appears in the future).

3.2. The personal data allowed for processing within the real Privacy policy is provided by the User by filling of a registration form on the Websites www.impex-fund.com, www.impex.blog in sections and includes the following information:

3.2.1. surname, name, User's middle name;

3.2.2. contact phone of the User;

3.2.3. e-mail address (e-mail);

3.2.4. address of delivery of Goods;

3.2.5. place residence of the User.

3.3. The websites www.impex-fund.com, www.impex.blog protect Data which are automatically transferred in process of viewing of advertizing units and in case of visit of pages on which the statistical script of system ("pixel") is set:

- IP address;
- information from cookies;
- information on the browser (or other program which provides access to advertizing show);
- access time;
- the address of the page on which the advertizing unit is located;
- referer (address of the previous page).

3.3.1. Switch-off of cookies can entail impossibility of access to the parts of the website of the E-commerce shop requiring authorization.

3.3.2. The websites www.impex-fund.com, www.impex.blog are realized by collection of statistics about IP addresses of the visitors. This information is used for the purpose of detection and the solution of technical issues, for monitoring of validity of the registered financial payments.

3.4. Any other personal information which is not stipulated above (history of purchases, the used browsers and operating systems, etc.) is subject to reliable storage and non-proliferation, except for the cases provided in items 5.2. and 5.3. real Privacy policy.

4. PURPOSES OF COLLECTING PERSONAL INFORMATION OF THE USER

4.1. The Administration of the websites www.impex-fund.com, www.impex.blog can use personal user information for:

4.1.1. Identifications of the User registered on the website of Online store for execution of the order and (or) signing of the contract of sale of goods in the remote way with www.impex-fund.com, www.impex.blog.

4.1.2. Providing to the User access to the personalized resources of the Websites www.impex-fund.com, www.impex.blog.

4.1.3. Establishments with the User of feedback, including the direction of notices, the inquiries concerning use of the Websites www.impex-fund.com,

www.impex.blog, rendering services, processing of inquiries and applications from the User.

4.1.4. Definitions of the location of the User for safety, prevention of fraud.

4.1.5. Confirmations of reliability and completeness of the personal data provided by the User.

4.1.6. Creations of the account for shopping if the User has agreed to creation of the account.

4.1.7. Notifications of the User Sayt of a condition of the Order.

4.1.8. Processings and receiving payments, confirmations of a tax or tax benefits, contest of payment, determination of the right to a credit line by the User.

4.1.9. Providing effective client and technical support to the User at emergence of problems of the Websites www.impex-fund.com, www.impex.blog connected with use.

4.1.10. Granting to the User from his consent, updates of production, special offers, information on the prices, the newsletter and other data on behalf of the websites www.impex-fund.com, www.impex.blog or on behalf of partners.

4.1.11. Implementation of advertizing activity with the consent of the User.

4.1.12. Providing access to the User to the websites or services of partners for the purpose of receiving products, updates and services.

5. WAYS AND TERMS OF PROCESSING OF PERSONAL INFORMATION

5.1. Processing of personal user information is carried out without restriction of term, any lawful way, including in information systems of personal data with use of the automation equipment or without use of such means.

5.2. The user agrees that the Administration of the website has the right to transfer personal data to the third parties, in particular, to courier services, the organizations of a mail service, to operators of telecommunication, is exclusive for implementation of the order of the User issued on the Websites www.impex-fund.com, www.impex.blog (at potential start of functionality of online store), including delivery of Goods.

5.3. Personal user information can be transferred to authorized bodies of the government of the Russian Federation only on the bases and as it should be, the established legislation of the Russian Federation.

5.4. During the losing or disclosure of personal data the Administration of the websites informs the User on loss or disclosure of personal data.

5.5. The administration of the websites takes necessary organizational and technical measures for protection of personal information of the User against illegal or casual access, destruction, change, blocking, copying, distribution and also against other illegal actions of the third parties.

5.6. The administration of the websites together with the User takes all necessary measures for prevention of the losses or other negative consequences caused by loss or disclosure of personal user information.

6. OBLIGATIONS OF THE PARTIES

6.1. The user is obliged:

6.1.1. To provide information on personal data necessary for use of the Websites www.impex-fund.com, www.impex.blog.

6.1.2. To update, add the provided information on personal data in case of change of this information.

6.2. The administration of the websites is obliged:

6.2.1. To use the obtained information only for the purposes specified in item 4 of the real Privacy policy.

6.2.2. To provide storage of confidential information in secret, not to disclose without preliminary written permission of the User and also not to carry out sale, exchange, publication, or disclosure of other possible ways of the transferred personal user information, except for items 5.2. and 5.3. real Privacy policy.

6.2.3. To take precautionary measures for protection of confidentiality of personal user information according to an order, usually used for protection of such information in the existing business conduct.

6.2.4. To carry out blocking of the personal data relating to the corresponding User from the moment of the address or inquiry of the User or his lawful representative or authorized body on protection of the rights of subjects of personal data for check, in case of identification of doubtful personal data or illegal actions.

7. RESPONSIBILITY OF THE PARTIES

7.1. The administration of the website which hasn't fulfilled the obligations bears liability for damages, suffered by the User in connection with unauthorized use of

personal data, according to the legislation of the Russian Federation, except for the cases provided by items 5.2., 5.3. and 7.2. real Privacy policy.

7.2. In case of loss or disclosure of Confidential information the Administration of the website doesn't bear responsibility if the given confidential information:

7.2.1. I became public property before her loss or disclosure.

7.2.2. Has been received from the third party until her receiving the websites by Administration.

7.2.3. Has been divulged with the consent of the User.

8. SETTLEMENT OF DISPUTES

8.1. Before appeal to the court with the claim for the disputes arising from the relations between the User of the websites and Administration of the websites obligatory presentation of a claim (the written offer on voluntary settlement of a dispute) is.

8.2. The recipient of a claim within 30 calendar days from the date of receiving a claim, in writing notifies the applicant of a claim on results of consideration of a claim.

8.3. At not reaching an agreement the dispute will be submitted to judicial authority according to the current legislation of the Russian Federation.

8.4. The current legislation of the Russian Federation is applied to the real Privacy policy and the relations between the User and Administration of the websites.

9. ADDITIONAL CONDITIONS

9.1. The administration of the website has the right to make changes to the real Privacy policy without the consent of the User.

9.2. New Privacy policy comes into force from the moment of her placement on the Websites if other isn't provided by new edition of Privacy policy.
